4. First-aid measures

Description of first aid measures

5. Fire-fighting measures

Extinguishing media

Methods for cleaning up Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Approach the spillage from upwind. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Appropriate engineering controls

Provide adequate ventilation. Observe any occupational exposure limits for the product or ingredients. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimize worker exposure. Ensure control measures are regularly inspected and maintained.
